From the Rector

On Sunday, Jan. 12, we celebrated the 50th anniversary of Bob L'Homme's ordination to the priesthood. It was a wonderful opportunity to celebrate Bob's special vocation — the special, unique way that God had called him to use his talents and to give his life proclaiming the Gospel and sharing the signs and means of God's love and grace. Bob's ministry took him to places like Trinity Episcopal Church on the south side of Chicago, to Flosmoor and Kankakee, to Peoria and serving struggling congregations in the Diocese of Chicago. Fortunately, his ministry also brought him to St. John's in Lafayette.

But anytime we celebrate someone's vocation, we are also celebrating the unique way God calls each of us to live out our baptismal vows. Some of us are called to the work of preaching, and teaching and sharing the sacraments or to the special work of table fellowship and of sharing the world's needs with the Church. Some of us are called to live out our baptismal vows in other contexts — at Purdue or in a public school, at the hospital, at the food bank, helping immigrants and refugees, or in a myriad of other ways. For instance, God has called Michael, Marylin, Linda and others to make beautiful music. God has called Aaron and Anna, Charlie and Greg to serve in leadership for this particular congregation. God has called Helen and Shirley and Sally and others to set the table and prepare us for worship. You may have noticed at the Epiphany pageant that God called little Aaron Sims to be a shepherd and wander all over the church. (And by all accounts, he did a bang-up job.) God is calling each of us in a myriad of ways to serve the Church that God loves, the people that God loves, the world that God loves. It is a wonderful gift to celebrate Bob's ministry as a sign and symbol of ways each of us are called to serve.

For my part, I am deeply grateful for five decades of Bob's ministry (and, for that matter, for Carol's ministry as well). I am also deeply grateful for each of you and for the ways you share God's love in this community. It is a great joy to worship this God with you, to share the love of God and our lives together, and to make Jesus Christ known in this time and place. — *Bradley Pace, bradleypace@stjohns-laf.org*

Dear sisters and brothers in Christ — It is an extreme honor and blessing to begin ministry with you as your interim associate rector during this Epiphany season. Seeing the light of Christ shine in our midst in and through us is a true gift. If you saw the bio in the bulletin, some of this may seem redundant.

Originally from South Dakota, I moved to West Lafayette via Japan, Denmark, Chicago and Glenwood, Ill. My undergraduate studies were in Anthropology, especially in the area of ethnography. My M.Div. took me to the Lutheran School at Chicago where I also completed my Th.M. and Ph.D. My dissertation "The Living Word in Daily Life: N.F.S. As a cradle Lutheran, I am very excited to learn more about Episcopalian/Anglican theology and worship.
