

From the Rector: Preparing for Pentecost Sunday



Last year, I was pretty sure we would be back in church by Pentecost Sunday, and that we would have a great party to celebrate. We may not be able to have a big party, but we should be able to regather for in-person worship by then (see "Regathering Update" on page 2), and that means we can celebrate Pentecost together. As we have done for several years now, we will hear the Gospel proclaimed in multiple languages. If you can read in a language other than English, please contact me and let me know. A Note About Email

Scammers are constantly looking for new ways to trick those of us who use email or social media. A few years ago, during our Capital Campaign, St. John's Treasurer Bill McInerney received an email from me asking me to send him info about depositing church funds. The email looked completely legit on the surface, but then he remembered that Teresa (our diligent Parish administrator), would never have trusted me with that kind of information! Fortunately, he reached out to me and confirmed that the email was not from me. This stuff is easy to fake now, so do be wary. Many of you have received emails or texts claiming to be from me. I get these kinds of emails all the time, too.

If you are ever unsure about an email coming from someone at St. John's, please call the church office and confirm. Also, please know that while I love using electronic communication (email, Facebook, and the like), I am often inundated with email. If it is a particularly busy time at church, I may get so far behind that your important message could go unanswered for several days. If you email me and need a response right away, please put "URGENT" or something similar in the subject line. You might also contact me directly by calling the office or my cell phone, 312-208-8791. I am always happy to receive an email from you, but if you need a response right away, calling my cell phone may be the most effective way to reach me. — Bradley Pace, bradleypace@stjohns-laf.org

You can help Mother Andrea and me by first reaching out to those folks directly. Call them, visit them, drop them a card. Secondly, you can let us know. Likewise, please let a member of the clergy know if you or a family member become seriously ill, are admitted to the hospital, or if some other crisis or need occurs.
